Citronellol

Max. Allowed concentration in Category 4 products: 13.3%

This product is compliant with the IFRA restriction established for it, as the maximum concentration of Citronellol in the final product would be 0.00016

Isoeugenol

For the purpose of this product, the allergens list is: Citral, Linalool, Limonene, Geraniol, Farnesol, BenzylBenzoate, Eugenol, Citronellol, Isoeugenol, BenzylSalicylate, however due to the type of product this is and the low levels contained, according to labelling requirements of EU Regulation 1223/2009, only the following allergens are required to be listed in your ingredients: Limonene,

According to IFRA standards, products containing linalool and/or limonene should contain an antioxidant in order to keep peroxides to the lowest practical level.

Whilst we do not consider this product to contain substantial amounts of these allergens, we would recommend the addition of an antioxidant in order to meet this requirement.

In the light of this information, it can be concluded that based on a weight of evidence approach and under reasonably foreseeable use, this product is safe for human health.

This report has been prepared from information provided by the responsible person as well as publicly available information on the ingredients used in the formulations.
